

Pursuant to the provisions of Point a, Clause 1, Article 32 of the Law on Securities No. 54/2019/QH14 amended by Point a, Clause 11, Article 11 of the Law No. 56/2024/QH15 stipulates: A public company being a joint stock company must fully meet the following 03 conditions: (i) Have a contributed charter capital of VND 30 billion or more; (ii) having at least 10% of the voting shares held by at least 100 investors who are not major shareholders; and (iii) having an equity of VND 30 billion or more.

According to the above regulations, VP Petrochemical Transport Joint Stock Company (stock code: VPA) does not meet the conditions on equity, because the equity as of 30/09/2025 is -87.469.158.291 VND.

The company has reported to the competent authorities for consideration and settlement and will make a specific report to your agency according to regulations.


